TERMS AND CONDITIONS

Registration and Payment

A deposit of \$250 per person is required at the time of booking. Final payment is due April 12. If your reservation is made within 6 days of departure, the entire cost of the tour must be paid at the time of confirmation.

Passports

Valid passports are required for travel to Scotland.

Baggage

Prices include portage of one piece of baggage per person. Baggage and personal effects are at the owner's risk throughout the time you are in Scotland.

Changes

Prices are based on current rates of exchange, tariffs and taxes. Erskine College and Seminary will not increase tour prices to cover increased costs, tariffs and taxes, or fluctuations in foreign exchange markets once full payment has been received. Erskine College and Seminary does reserve the right to withdraw a tour or any part of it to make such alterations in the itinerary or with the tour inclusions as it deems necessary or desirable due to delays or events beyond its control. Itineraries and arranged sightseeing are subject to change at any time due to unforeseen circumstances.

Promotional Photography

Erskine College and Seminary requests the right to take photographs during the operation of any program or part thereof and to use them for promotional purposes. By booking the tour participants agree to allow their images to be used in such photographs. Participants who prefer that their images not be used are asked to identify themselves to the tour manager at the beginning of the tour.

Air Transportation

Erskine College and Seminary does not arrange flights. Should you cancel or change your air reservation before or after your departure, cancellation penalties from the airline may apply.

Limits on Responsibility

Erskine College and Seminary does not own or operate an entity which is to or does provide goods or services for your tour. It purchases transportation, hotel and other lodging accommodations, restaurant meals, ground handling and other services from various independent suppliers. All such persons and entities are independent contractors. As a result, Erskine College and Seminary is not liable for any negligent or willful act of any such person or entity or of any third person.

In addition and without limitation, Erskine College and Seminary is not responsible for any injury, loss, death, inconvenience, delay or damage to personal property in connection with the provision of any goods or services whether resulting from but not limited to acts of God or force majeure, illness, disease, acts of war, civil unrest, insurrection or revolt, strikes or other labor activities.

Risks: There are certain inherent risks in travel. Participant assumes all such risks and regard to these.

Arbitration Agreement: Any controversy or claim arising out of or relating in any way to these Terms and Conditions, to the Responsibility Clause, to the information relating in any way to the tour, shall be settled solely and exclusively by binding arbitration in South Carolina, in accordance with the rules of the Arbitration Association then existent.

Participants Representations: The participant represents that neither he nor she nor anyone traveling with him or her has any physical or condition or disability that could create a hazard to himself or herself or other members of the tour. Erskine College and Seminary reserves the right to decline to accept anyone on a trip. It further reserves the right to remove from the trip, at his or her sole expense, anyone whose condition is such that he or she could create a hazard to himself or others, or otherwise impact the enjoyment of other participants on the tour.
